

PETITION: TRAIL/SIDEWALK SNOW REMOVAL

Guidelines & Consideration Process

By submitting this petition, we (the undersigned) acknowledge:

- We have read and understand the Winter Maintenance of Sidewalks and Trailways Policy.
- We understand the policy's criteria that the City uses to consider adding a new segment of trail/sidewalk to City plowing and confirm that our segment meets the criteria:

(Please circle all that apply):

- Major Arterial Road: thoroughfare roads with 4+ traffic lanes, traffic volumes greater than 5,000 vehicles per day, and speed limits of 45mph or greater.
- Community Collector: thoroughfare roads with 2 traffic lanes (with safety lanes/shoulders) or 4 full traffic lanes with volumes greater than 3,000 vehicles per day and speed limits of 35-45 mph.
- Neighborhood Collector: local streets approximately 1 mile in length with 2 traffic lanes (with safety lanes/shoulders), traffic volumes less than 3,000 vehicles per day and speed limits of 35 mph or greater.
- School Walking Route: trails and sidewalks that are relied upon by school districts for designated walkers under their bus transportation policy.
- Transit Route: trails and sidewalks that are located along scheduled transit routes with designated transit stops (i.e. signs, shelters, benches or stations) maintained by the MVRTA and are also located within or adjacent to high density residential area, retail centers or high density employment centers.
- Signatures representing a minimum of 50 properties lying within ½ mile of segment are required. All signature sheets shall be accompanied with this sheet and the policy.
